

OMDC Trillium Book Award Contest (the “Contest”)
Official Contest Rules (the “Rules”)

The Contest is subject to all federal, provincial, and municipal laws. Void where prohibited.

NO PURCHASE NECESSARY

1. **Contest Sponsors:** The Contest is sponsored by the Ontario Media Development Corporation, (“OMDC”). This Contest will be run in accordance with these Rules, subject to amendment by OMDC. Entrants must comply with these Rules, and, by entering the Contest, will be deemed to have received, understood and accepted the Rules. This promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook.
2. **Contest Period:** The Contest starts at 9:00am (Eastern Standard Time) on Monday, June 13 2016 and continues until 11:59pm (Eastern Standard Time) on Wednesday, June 22, 2016 (the “**Contest Period**”).
3. **Eligibility:** The Contest is only open to legal residents of Canada (excluding Quebec) who are at least 18 years of age or older. Employees of the OMDC and its parent and affiliated companies, subsidiaries, Contest suppliers and judges (where applicable), and immediate family members of any such person (regardless of where they live) or those with whom any such persons are domiciled are not eligible to enter the Contest. Entries are limited to individuals only; commercial enterprises and business entities are not eligible to enter the Contest.
4. **How to Enter:** No purchase necessary.
During the Contest Period, comment on the Trillium Book Award article for a chance to win a collection of the nominated books.
5. **Prize:** There is one (1) Prize available to be won each consisting of:
One (1) Set of nine (9) Trillium Book Award Nominated Books. Approximate retail value \$175.00. Prize must be accepted as awarded and are not substitutable, transferable or convertible to cash. Prize will be shipped to the contest winner within 30 days of the winner being verified and confirmed.
6. **Winner Determination:** The eligible winner(s) will be selected by a random draw from all eligible entries received during the Contest Period on or around June 23, 2016 at Cottage Life’s office at 130 Merton Street, Toronto, Ontario. Odds of winning depend on the number of eligible entries received during the Contest Period.
Cottage Life will contact the selected entrant(s) through the article comment section. If a selected entrant does not acknowledge winner notification attempts within forty-eight (48) hours after Cottage Life’s first attempt at contact or, if contacted, does not claim his/her prize, or does not meet all of the Contest conditions outlined in these Rules, the selected entrant will be disqualified and forfeits his/her prize, and another entrant may be selected from among all remaining eligible entries whom Cottage Life will attempt to contact, and who will be subject to disqualification in the same manner. This process will

continue until contact is made with a selected entrant who meets Contests requirements or until there are no more eligible entries, whichever comes first. Cottage Life is not responsible for failed attempts to notify any selected entrant. Upon prize forfeiture, no compensation will be given.

8. **Winner Conditions:** To be declared a winner, a selected entrant must first: (i) have complied with, be in compliance with, and continue to comply with the Rules; (ii) correctly answer, unaided, a time-limited, mathematical skill-testing question to be administered by Contest Sponsor; and (iii) sign and return a Declaration and Release form within a specified period of time confirming compliance with the Contest Rules and releasing the Releasees (as defined below) from liability in connection with the Contest.
9. **Tampering:** All entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means, or do not conform to or satisfy any condition of the Rules may be disqualified by Cottage Life. The venue shall only be Toronto, Ontario. The invalidity or unenforceability of any provision of these Rules shall not affect the validity or enforceability of any other provision. If any provision is determined to be invalid or otherwise unenforceable, these Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
